

ORACLE CARD SELFIE SWEEPSTAKES RULES

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN.

OFFERED ONLY TO LEGAL RESIDENTS OF THE 50 UNITED STATES, THE DISTRICT OF COLUMBIA, CANADA, GREAT BRITAIN, AUSTRALIA, NEW ZEALAND, and EUROPE.

VOID WHERE PROHIBITED.

1.Eligibility. The Oracle Card Selfie Sweepstakes is open only to legal residents of the 50 United States and the District of Columbia, Canada, Great Britain, Australia, New Zealand, and Europe and who have reached the age of majority in their country of residence and are at least 21 years of age or older at time of entry.

Subject to all applicable federal, state, and local laws and regulations. Void where prohibited or restricted by law. During the Sweepstakes Period, entrants will take and upload a selfie with any Colette Baron-Reid Oracle Card or Colette Baron-Reid Oracle Deck in a public post shared to their personal Instagram or Facebook accounts. Post captions must include a brief takeaway, reflection, or meaning of that specific Oracle Card or Deck and what it means to you, along with the hashtags #OracleCardSelfie, #ColetteBaronReid, and the hashtag of the corresponding deck the Oracle Card is from, e.g., #GoddessPower, #SpiritAnimal, #MysticalShaman, #PostcardsFromSpirit, #WisdomoftheOracle, #EnchantedMap, #GoodTarot, #HiddenRealms, #WisdomofAvalon, #HouseofNight, or #OracleofE.

4. Entry Requirements. All entrants must share on social media (Facebook or Instagram) at least one selfie photo, held within the sweepstakes timeframe, with at least one of Colette Baron-Reid’s Oracle Card Decks or Cards appearing in the photo. Photo must be shared on a personal Facebook or Instagram social media account in a public post and hashtag at least one

photo with #OracleCardSelfie, #ColetteBaronReid, and the hashtag of the corresponding deck the Oracle Card is from, (e.g., #GoddessPower, #SpiritAnimal, #MysticalShaman, #PostcardsFromSpirit, #WisdomoftheOracle, #EnchantedMap, #GoodTarot, #HiddenRealms, #WisdomofAvalon, #HouseofNight, or #OracleofE) in the description. **Settings for post on Facebook must be set to “public”. Instagram account on which post is shared must be public.**

All entries submitted in accordance with these Official Rules are eligible to win (“Eligible Entries”).
